## **PUBLIC HEARINGS**

Public Hearing #1- Budget Hearing on Tentative Budget Fiscal Year 6/1/2015 to May 31, 2016

Trustee Quigley motioned to open Public Hearing #1; motion was seconded by Trustee Alfasi and upon roll call was carried by a vote of 4-0.

- Representatives from the Tuckahoe Library requested money in the budget for a full time adult librarian.
- Trustee Quigley stated that the library is an essential service provided by the Village. Trustee Luisi explained that the library budget was not cut but there is no money available for a full time adult librarian. Trustee Alfasi expressed his displeasure with the current budget and says there is more work to be done. Mayor Ecklond explained that the lion's share of the budget goes to DPW and police. He requested a system to be put in place to monitor who utilizes the library.
- Trustee Luisi motioned to close Public Hearing #1; motion was seconded by Trustee Alfasi and upon roll call was carried by a vote of 4-0.

 Adopting a Local Law concerning an amendment to Section 8-1 of the Village of Tuckahoe Zoning Ordinance of 2001 thereof that would decrease the number of Planning Board members from seven (7) to five (5) LOCAL LAW NO. 2 OF 2015

# A LOCAL LAW AMENDING SECTION 8-1 OF THE VILLAGE OF TUCKAHOE ZONING ORDINANCE OF 2001, ENTITLED "PLANNING BOARD"

WHEREAS, a resolution was duly adopted by the Village Board of Trustees of the Village of Tuckahoe, New York for a public hearing to be held by the Village Board on the 13 day of April 2015 at 8:00p.m. at Village Hall, 65 Main Street, Tuckahoe, New York to hear all interested parties on a proposed Local Law entitled, A LOCAL LAW CONCERNING AN AMENDMENT TO SECTION 8-1 OF THE VILLAGE OF TUCKAHOE ZONING ORDINANCE OF 2001 THEREOF THAT WOULD DECREASE THE NUMBER OF PLANNING BOARD MEMBERS FROM SEVEN (7) TO FIVE (5); and

WHEREAS, notice of said public hearing was duly advertised in the Journal News, the official newspaper of said Village, on the 9 day of March, 2015; and

WHEREAS, said public hearing was duly held on the 13 day of April, 2015, at 8:00p.m.at Village Hall, 65 Main Street, Tuckahoe, New York, and all parties in attendance were permitted an opportunity to speak on behalf of or in opposition to said proposed Local Law, or any part thereof; and

WHEREAS, it has been determined by the Village Board of said Village that adoption of said proposed Local Law would not have a significant effect upon the environment, thus the Village Board adopts a Negative Declaration pursuant to SEQRA; and

WHEREAS, the Village Board, after due deliberation, finds it in the best interest of said Village to adopt said Local Law.

Be it enacted by the Village Board of Trustees of the Village of Tuckahoe as follows:

Section 1.

Section 8-1.1 Of the Village of Tuckahoe Zoning Ordinance of 2001, entitled "Establishment" in the "Planning Board" section (Section 8-1) of said Zoning Ordinance is amended, reenacted and restated as follows:

# 8-1. PLANNING BOARD

8-1.1. Establishment. There shall be a Planning Board of {**seven}** five members pursuant to the provisions of the Village Law, with all the power and duties prescribed by law and by this chapter. The Board of Trustees shall designate one member of the Planning Board to serve as Chairperson of such Board for a period of one official year. In addition to the {**seven**} five regular members of such Board, the Board of Trustees may appoint two ad hoc members to the Planning Board. Such ad hoc members shall serve on the Planning Board whenever absences or conflicts of interest of regular members prevent {**seven**} five regular members from hearing an application or applications. The powers and duties of the Planning Board are summarized and more particularly specified as follows, provided that none of the following provisions shall be deemed to limit any power of the Planning Board.

Section 2. Insofar as the provisions of this Local Law are inconsistent with the provisions of any other local law, the provisions of this Local Law shall be controlling.

Section 3. This Local Law shall take effect immediately.

Section 4. The Village Clerk be and she hereby is directed to enter this Local Law in the minutes of this meeting and give due notice of the adoption of said Local Law to the Secretary of the State of New York. New Matter Underlined

04/13/2015 Board Meeting Tonight's Board Meeting to open up the public discussion on changing the Elected terms to 4 years and the Elections to biennial.

05/11/2015 Board Meeting We intend on continuing this discussion

06/08/2015 Board Meeting We intend on continuing this discussion and then pass a resolution on the matter. (If the resolution is approved then the 30day window for a permissive referendum starts)

07/10/2015 If there is no permissive referendum filing (no written petition signed by approximately 800 registered voters in Tuckahoe opposing the 06/08/15 resolution) then the matter becomes final.
