BOARD OF TRUSTEES MEMBER REPORTS

► TRUSTEE Giordano is still in contact with the MTA regarding the horn blowing of the trains and the replacement with P.A. warnings. It is progressing. He

announced the next Planning Board meeting scheduled for July 21st. Items on the agenda are 100 Main St., 50 Columbus Ave., 109 Marbledale Rd., 10 Fisher Ave., 73 Main St., 69 Main St., and 100 Pleasant Ave. Zoning is scheduled for August 12th. The Board is looking at other communities' building fees. Lowering the fees may lessen the burden to our residents. He said the Fireworks celebration was great and thanked David Pope, the Generoso Pope Foundation and John Galluzzi.

►TRUSTEE

Luisi, on behalf of Jennifer Vetromile, thanked all that attended the Senior 45th Celebration. He gave an update on senior activities. The seniors are looking for volunteers and slightly used articles for their bazaar on October 3rd. The Senior Center is closed in August and reopens September 8th. He thanked John Galluzzi and the Village Hall staff for making the fireworks special and thanked the Generoso Pope Foundation and Grucci. On a sadder note, he mentioned the two young lives that were lost from our community. On behalf of the Village Board he extended condolences to the family of John Crimmins.

►TRUSTEE

Alfasi said the Zoning Committee has items for consideration that will be on our website. He thanked all for coming to the fireworks and commented that all were well mannered and that there were no problems.

►TRUSTEE

Leo gave an updated on library events for children, teens and adults.

► MAYOR

Ecklond thanked Amy Paulin for her tireless work with regard to the 3% hotel tax. This money will go to police enforcement and sanitation. We are still waiting for the governor to sign it. The governor signed Yonkers but as of yet has not signed Tuckahoe's. Trustee Alfasi commented that as everyone knows, he is not in favor of any taxes; but he wants everyone to know that he supports the hotel tax. The Mayor gave an update on the streets paved. The schedule is on the website. Due to the rising costs of paving, we may look at a long term paving plan. Currently we use grant money. Finally, just to wrap it up, the Mayor knew when we hired an administrator he would get things organized. He and Gary Gjertsen need more direction from the board on items that are not discussed at the work session or at the board meetings; therefore we have decided to have monthly administrator's meeting to discuss items such as food establishments, banner issues, codes, and building fees. Our first meeting is next Monday. At this meeting we will discuss the traffic light in Depot Square with a traffic engineer

SECOND OPPORTUNITY TO ADDRESS THE BOARD

Albert Stein from 14 Westview Avenue presented the board with a petition and comments regarding fast/casual food regulations. He said he would like restrictions eliminating fast food. He wants the board to come to a decision before the Marriot comes because he does not want Applebee's, I Hop, or Hooters on Marbledale Road. We don't want Marbledale Road to be a fast food alley.

Ladislao Castellanos, 56 Jefferson Place, has parking and traffic issues. The 4 hour restriction is not enough. He suggested a 2 hour restriction. People going to businesses on Main Street will park on Jefferson for 4 hours to avoid paying the meters. He thanked Lt Stabile who has tried to help but with new curb cuts and more businesses parking and traffic is a problem for the residents of Jefferson Place. Castellanos requested possibly a speed bump or stop sign on Main Street. With regard to last month's meeting Mr. Castellanos is glad the board tabled the banner resolution, is against work on Sundays, and is against fast food restaurants.
