- 2) Trustee Leo made a motion approving the use of certain streets for a Walkathon by the Immaculate Conception School on Friday, October 9th, rain date, Friday, October 16th beginning at 10:00 AM. The Walkathon will start at the ICS parking lot then proceed down Winterhill Rd to Depot Square and back. Certificate of insurance will be provided; motion was seconded by Trustee Giordano and upon roll call, motion was carried by a vote 4-0.
- 3)Trustee Leo made a motion appointing Henningson Durnham & Richardson Architectural and Engineering, PC (HDR) as environmental consultant for the 2015 fiscal year in accordance with the proposed Master Agreement received September 17, 2015; motion was seconded by Trustee Alfasi and upon roll call, motion was carried by a vote 4-0.

Mayor Ecklond explained that this is a consultant firm that the Village decided upon. The costs will be reimbursed by the applications with no cost to the village.

- 4) Trustee Leo made a motion setting a public hearing to consider proposed modifications to the village code regarding restaurants and fast food establishments; motion was seconded by Trustee Giordano and upon roll call, motion was carried by a vote 4-0.
- 5) Trustee Leo made a motion declaring an Ingersoll rand model UC-200 air compressor and a 2001 Dodge 1-ton dump truck as surplus for sale; motion was seconded by Trustee Alfasi and upon roll call, motion was carried by a vote 4-0.

- 6) Trustee Leo made a motion accepting a bid in the amount of \$2,236 for a Segway Personal Transporter and \$76 for a Vespa Radago Scooter; motion was seconded by Trustee Alfasi and upon roll call, motion was carried by a vote 4-0.
- 7) Trustee Leo made a motion authorizing the Dance Gallery a to perform a Halloween Flash Mob on Friday Oct. 30<sup>th</sup> in front of the building at 25 Main Street; motion was seconded by Trustee Giordano and upon roll call, motion was carried by a vote 4-0.

- 10)BOND RESOLUTION, DATED SEPTEMBER 17, 2015, AUTHORIZING THE ISSUANCE OF UP TO \$801,720 AGGREGATE PRINCIPAL AMOUNT SERIAL BONDS OF THE VILLAGE OF TUCKAHOE, COUNTY OF WESTCHESTER, STATE OF NEW YORK, PURSUANT TO THE LOCAL FINANCE LAW, TO FINANCE THE COSTS OF (I) THE ACQUISITON OF POLICE VEHICLES AND (II) THE PAYMENT OF JUDGMENTS AND SETTLED CLAIMS TO BE PAID BY THE VILLAGE RESULTING FROM TAX CERTIORARI PROCEEDINGS BROUGHT PURSUANT TO ARTICLE 7 OF THE NEW YORK REAL PROPERTY TAX LAW

Trustee Alfasi questioned if this is a program to replace police vehicles on a steady basis. David Burke clarified by explaining that keeping police cars a long time is costly in repairs. This program in place, would be replacing 1 vehicle one year and 2 vehicles the next year at a very good rate, right about when the warranties will expire. We will have a nice fleet without incurring maintenance costs.

Trustee Alfasi asked that if we bond this year, does it mean that we do not have to bond for police vehicles next year. David Burke assured him, yes, we do not have to bond for police vehicles next year.

Trustee Alfasi explained that he has been wrestling with a few of these bond issues and has discussed his concerns with the board. Although he is hesitant, he will vote in favor of all the bonds. He is not happy with bonding \$150,000 new money but the costs for bonding at this time are cheap. There is a \$30,000-\$50,000 cost involved in bonding money including advertisement. He came to the meeting thinking that he would vote against some of the bonds but after carefully thinking it through has decided to vote in favor.

Trustee Leo explained that it costs a lot of money to bond and it makes financial sense to do it all at once. The new bond money for vehicles and DPW is under \$200,000.

Trustee Giordano made a motion to approve resolution #10; motion was seconded by Trustee Leo and upon roll call, motion was carried by a vote 4-0.

Trustee Giordano asked David Burke to explain this bond to us. Mr. Burke explained that it is three main items; \$20,000 for a new server at Village Hall, \$10,000 to match a grant received by the library for LED lighting, and \$15,000 to bandage the elevator in Village Hall.

Mayor Ecklond stated that the elevator is used by our ¼ of a million dollar a year tenant on the third floor. Trustee Alfasi added it is a safety issue.

Trustee Leo made a motion to approve resolution #11; motion was seconded by Trustee Alfasi and upon roll call, motion was carried by a vote 4-0.

Mayor Ecklond explained that we have already received over a million dollars for the project and this is our share to get the underground utilities, pocket park, and street paving done. He asked Mr.

the \$100,000 remainder. Mr. Burke explained that is must go back to the principle. Trustee Alfasi emphasized that 2/3's of this project was paid for by grants and the developer. This is a bill for services already rendered. It's something that we have to pay.

Burke what happens if we do not need the \$650,000, say we only need \$550,000, what happens to

David Burke explained this is for the salt shed and for a new roof on the old DPW building that the board has decided to keep. It is where the mechanic works.

Mayor Ecklond explained that we need a new heating system in the mechanics shop because when the doors open all the heated air goes out. The one we have now is not efficient. The salt shed needs a cover and we need to make sure no salt goes into the storm drain. The salt must not be exposed and we do not want to lose that investment.
