Item #1 85 – 89 Main St. Site Plan

Marieta Delisa, applicant, requested the expansion of her existing restaurant to the retail store next door. The new space will consist of the dining area. The plans are for nine tables with four chairs at each table. There will be two new handicap restrooms. There will be no changes to the existing kitchen. The same counter and stools that are currently in the restaurant will remain. The new dining area would be placed in the retail store area. The existing entrance will be the main entrance to the restaurant and there will be three separate

DESCRIPTION OF PROJECT: Applicant has an existing restaurant located at 87 Main Street, Tuckahoe. Applicant is now seeking to expand its seating area into a vacant storefront adjacent to its restaurant with an address of 89 Main Street Tuckahoe. Applicant further seeks to reconfigure its restrooms.

SEQRA RESOLUTION
