## Item #1 Approval of Minutes April 23, 2013

Chairwoman Nieminen motioned to approve the minutes of the April 23, 2013 meeting. This motion was seconded by Member Baez and unanimously carried by the Board with a vote of 2-0.

## Item #2 173 Marbledale Road New Awning

Mr. David Barbuti, the Architect, representing "Broken Bow Brewery" presented an application for two new awnings to be placed over the doors. The two awnings will project 18 inches off the building. The first awning will measure 17 feet long and the second awning is 5 feet long. The color of both awnings is black and the material will be fire retardant. The applicant will submit the certificate stating that the awnings are fire retardant. The awnings will be closed on all sides. Member Baez asked how many brackets are used to attached the awning. Mr. Barbuti said the 17 foot awning will have a bracket every 2 to 3 feet and the 5 foot awning will have 3 brackets.

Chairwoman Nieminen made a motion to approve the awnings as presented for "Broken Bow Brewery". Member Baez seconded the motion and it was unanimously carried by the board with a 2-0 vote.

## Item # 3

Lee Smith of East Coast Signs, representing "Broken Bow Brewery", presented a revised rendering of the sign for "Broken Bow Brewery". The sign will be stud mounted and flush with the façade. This sign will be placed above the 17 foot awning. The letter size for "Broken Bow Brewery" is 15 inches high, the

depth is 1 ¼ and the color of the letters is black. "Broken Bow Brewery" will be on one line. There will also be gooseneck lighting over the sign. The lights will not hang over the letters. Spec's for the lighting has been submitted. The second sign will be placed on the side of the building. This sign measures 18 inches by 58 inches. There is a black border around the sign with a Arizona Tan color background. The letters will be black single v-groove carved, measuring 5 ¾ inches. Member Baez asked if they intend to add a logo on either side of the main sign. Mr. Smith said they have not discussed that at this time.

Chairwoman Nieminen made a motion to approve the signs as presented for "Broken Bow Brewery". Member Baez seconded the motion and it was unanimously carried by the board with a 2-0 vote.
