Item #1 16A Fisher Avenue New Sign

Michael Santoliguido of San Signs, representing "Elite Wash and Fold" proposed one sign. Member Pushkal asked if the size of the sign could be exactly like the sign for the Shoe Repair Shop. Member Nieminen also asked that they shrink the lettering so that there would be blank space at either end of the sign. Mr. Santoliguido inquired about a Directory Sign to be placed on the side on the building. Discussion regarding the Directory Sign took place and Mr. Santoliguido said if the tenants agree, he would then propose to place the sign on the parking lot side of the building.

A motion was made to accept the application as submitted for 16A Fisher Avenue, by Member Pushkal with a stipulation that it's the same size and color as the "Shoe Repair Shop" sign, seconded by Member Nieminen and unanimously carried by the board with a vote of 3-0.

Item #2 108 Main Street

New Signs and Arm Sign

Michael Santoliguido of San Signs, representing "The Quarry Restaurant Bar & Lounge" proposed 3 signs and 1 arm sign. First sign measuring 18 X 236 inches "THE QUARRY", the second sign measuring 18 X 168 inches "RESTAURANT", and the third sign measuring 18 X 168 "BAR & LOUNGE". The first letter in each word in 10 inches and the rest of the letters in 8 ½ inches. The arm sign is 7 X 24 inches, letter size is 3 inches and the color of the letters will be in 23 Karat Gold Florentine Swirl. Arm Sign to be placed 7 feet 6 inches from grade. Discussion regarding other arm signs to be placed on the building took place. Chairwoman Ciaramella made a resolution to accept the proposed signs "The Quarry" "Restaurant" "Bar and Lounge" as presented and that the arm sign have maximum 3 inch lettering, measures 7 X 24 with a 30 inch brace for the sign. The color is 23 Karat Gold Florentine Swirl. Member Nieminen added that the lettering be brought down so that there is some blank space on either end. Member Pushkal motioned to accept as amended, Second by Member Nieminen and unanimously carried by the board with a vote of 3-0.
