**Item #1 Approval of Minutes December 21, 2015**  
**Member Baez motioned to approve the minutes of the December 21, 2015 meeting. This motion was seconded by Chairwoman Nieminen and was carried by the Board with a vote of 2-0.**

**Item #2 16A Fisher Avenue New Sign**  
Mrs. Ashley Cermele, business owner of "Ashley Lauren Beauty Lounge" presented an application for a new sign and a window sign. The sign is an existing sign that will be painted in black with white lettering and a white border. The sign measures 22 inches by 118 inches. The window sign will be white vinyl letters. Chairwoman Nieminen noted that the window letters cannot exceed 3 inches in height and they presented a 15 inch letter for the "L" in "Lauren". There was discussion regarding the size of the lettering on the window. It was noted that the other businesses on the street had larger than 3 inch lettering on their windows. Mr. Dominick Tolli, of Mr. Signs, asked if they can come to an agreement to approve the sign and return next month with a new rendering of the sign with smaller letters. It was suggested that the "L" in "Lauren" be 9 inches and reduce the other letters in proportion. The phone number, website and email address will be 3 inches and 2 inches in height.

Chairwoman Nieminen made a motion to approve the sign for “Ashley Lauren Beauty Lounge” without the border and the graphics remain as presented. The letter “L” in Lauren will not exceed 18 inches. The applicant will return next month with new rendering of the window graphics with the “L” in “Lauren” 9 inches and the remaining letters in proportion. “Beauty Lounge” will be 3 inches, the phone number in 3 inches and the website in 2.5 inches. Member Baez seconded the motion and was unanimously carried by the board with a vote 2-0.
